

# **Academic Certification Program Highlights**

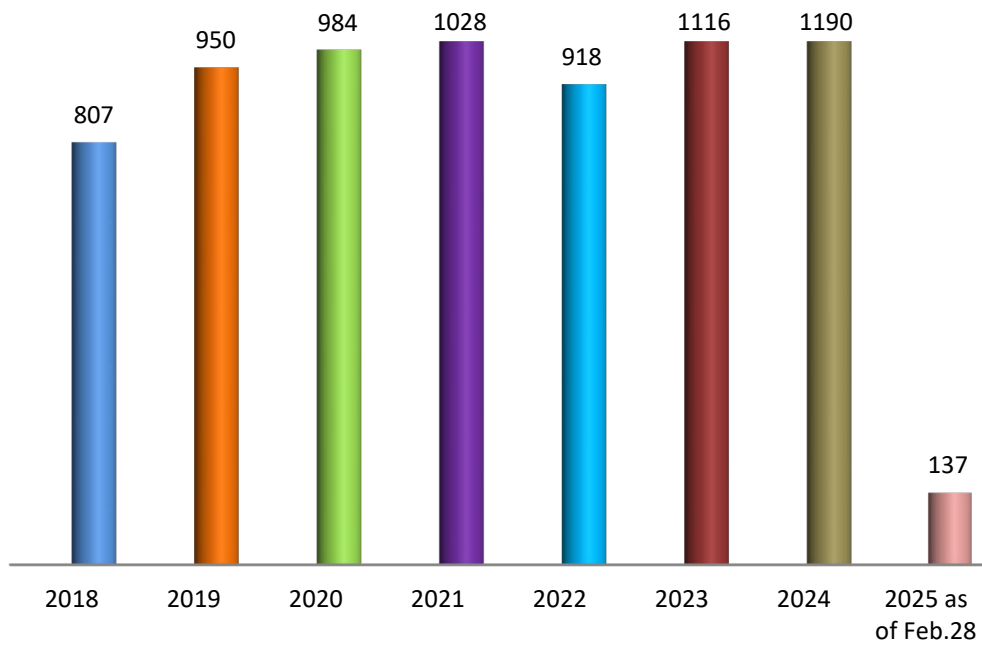
## Since 1976

Academic Certification is the first mandatory required step towards registration/licensure which consists of Academic Certification (Education), Internship (Experience) and Examination.

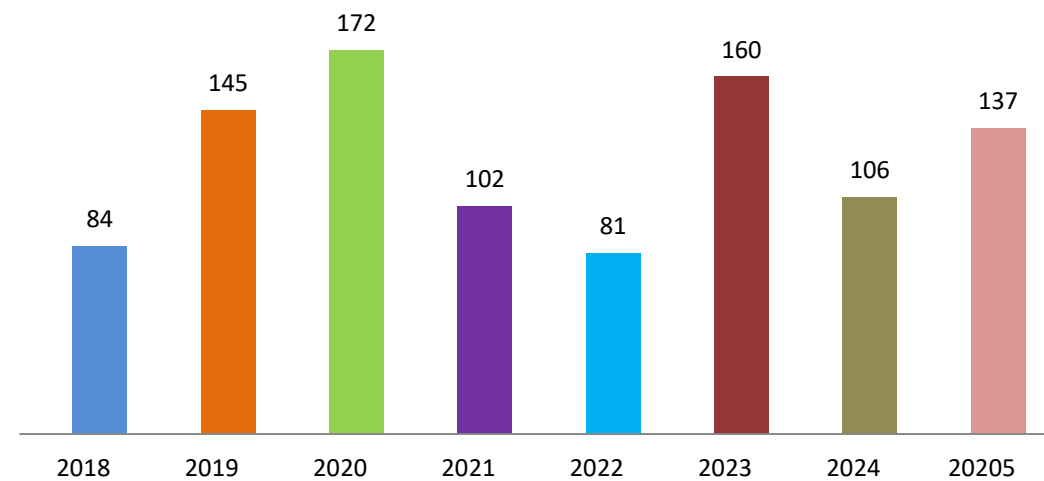
The CACB's Certification confirms an individual's academic qualifications compliance with [the Canadian Education Standard \(CES\)](#) in Architecture for entry into the profession.

CACB works on behalf of [the Regulatory Organizations of Architecture in Canada](#) (ROAC) to assess the educational qualifications of individuals holding professional degrees or diplomas in architecture against the Canadian Educational Standard requirements.

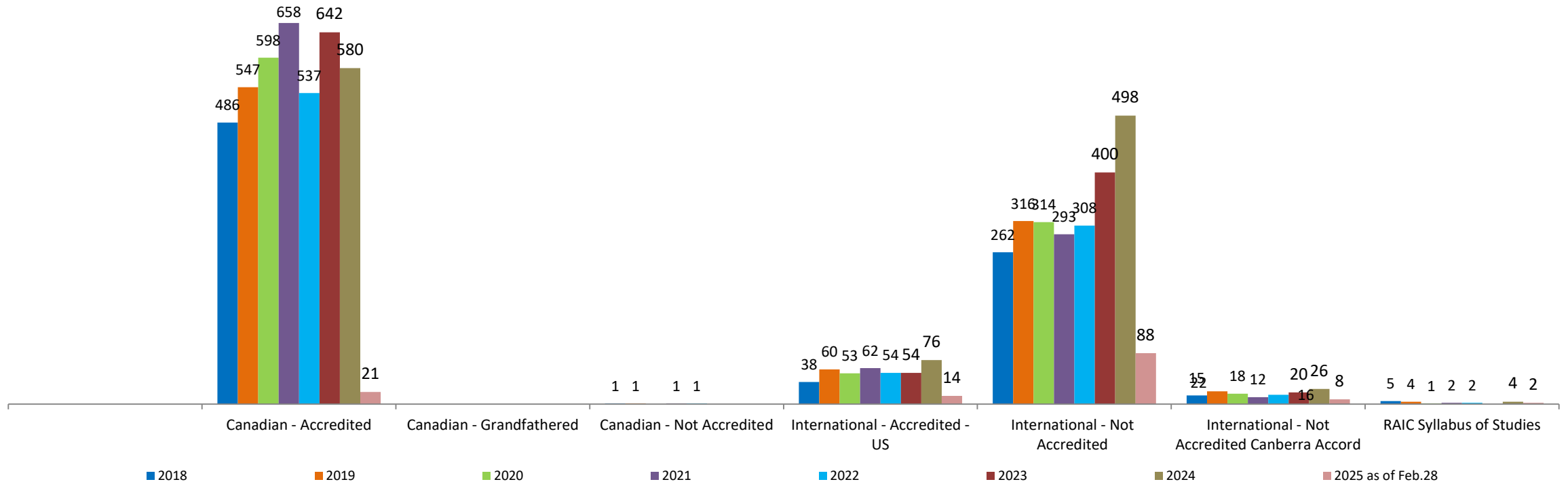
Total Applications received



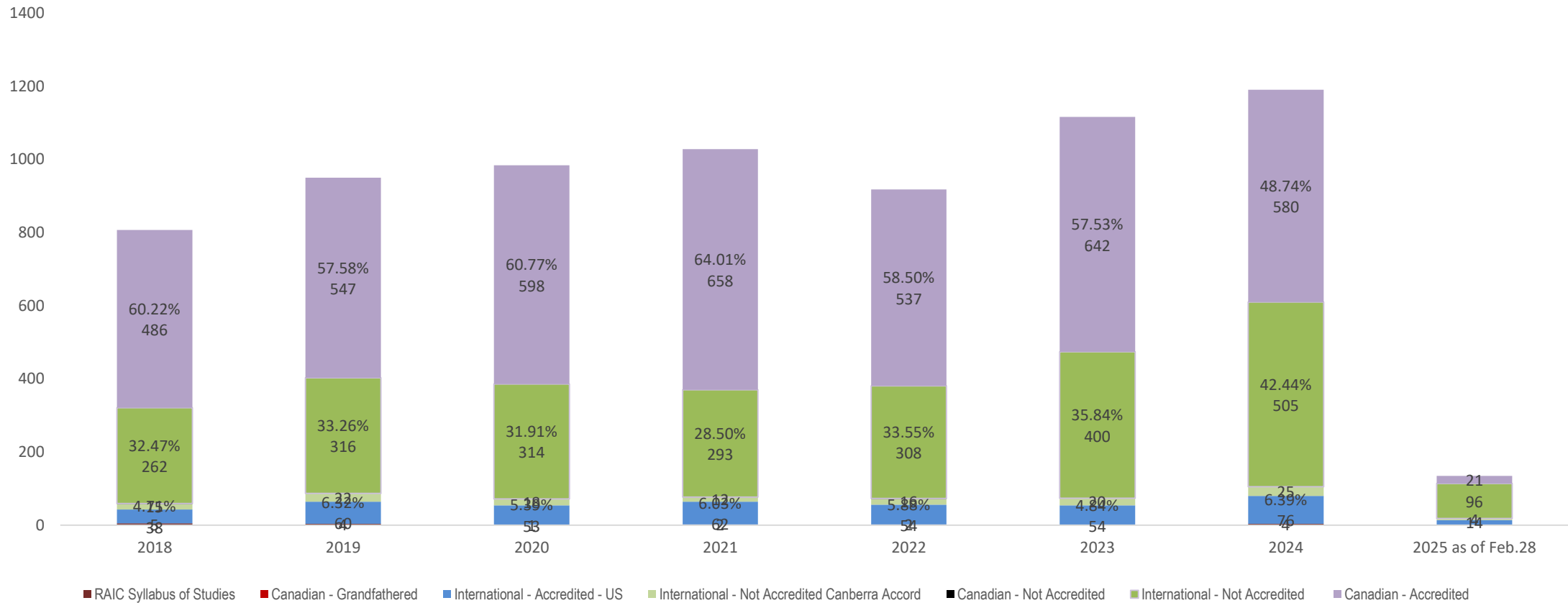
Total applications received as of February of each year

### Total Applications received



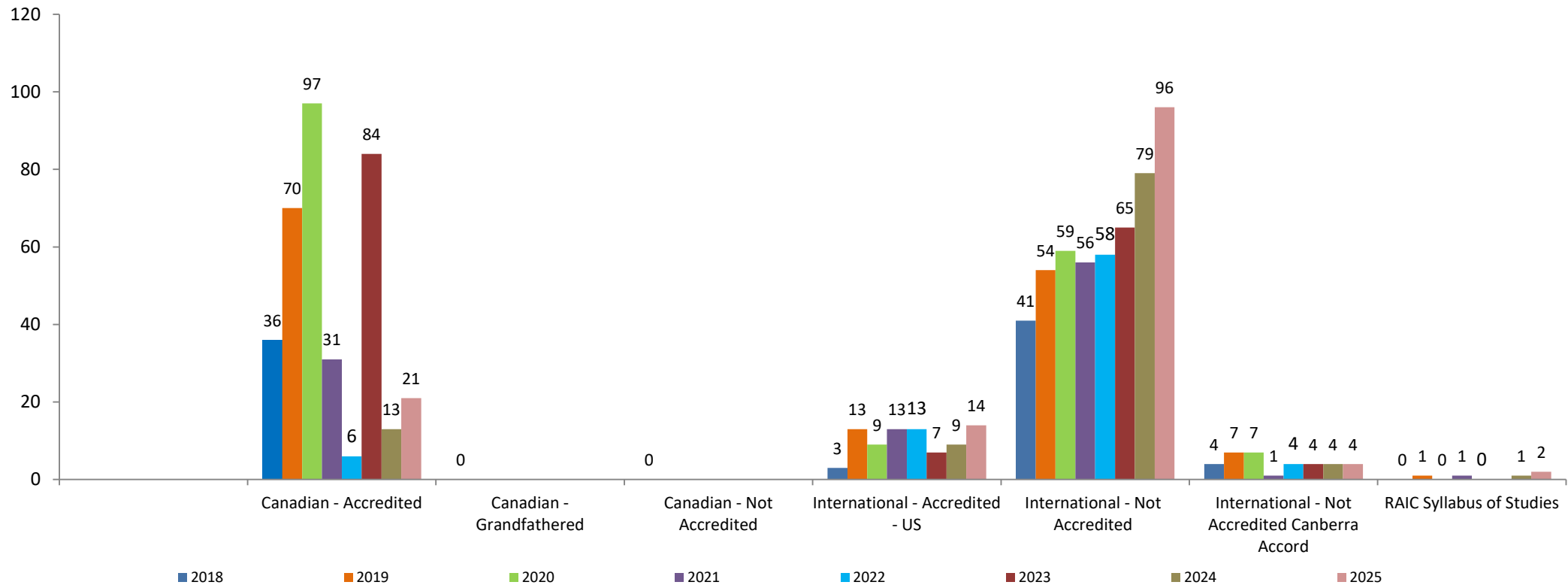

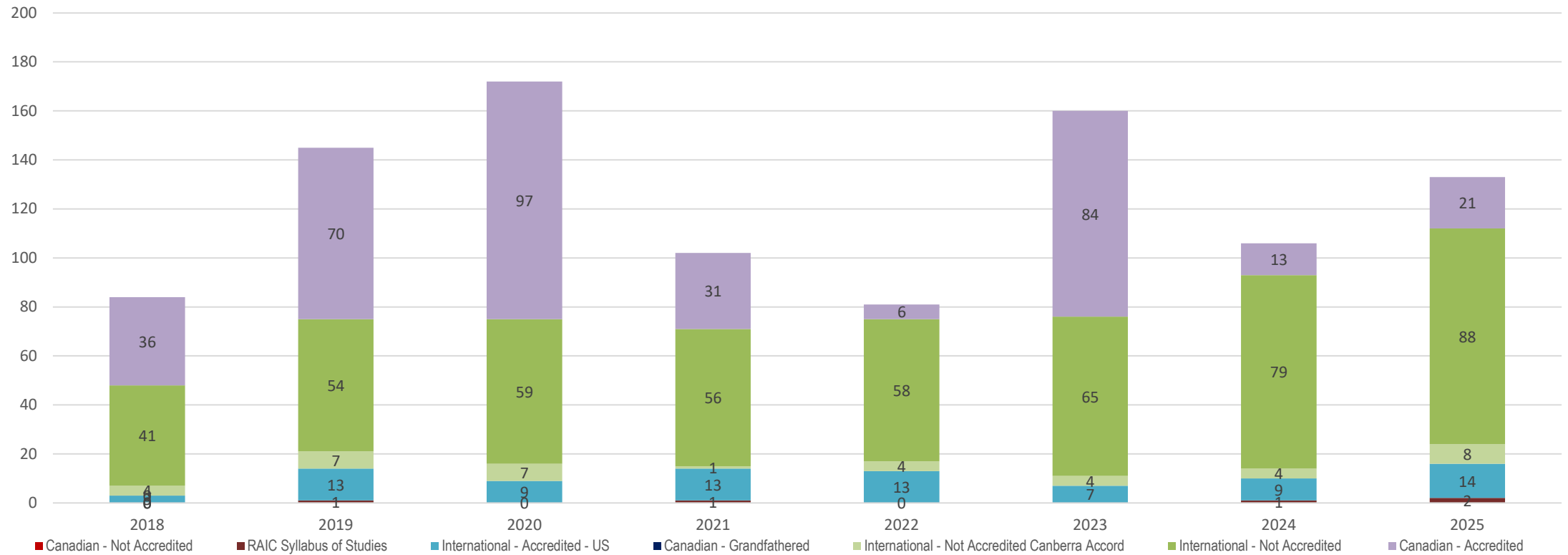
Total applications received showing Modes of Certification proportions

Total applications received as of February of each year

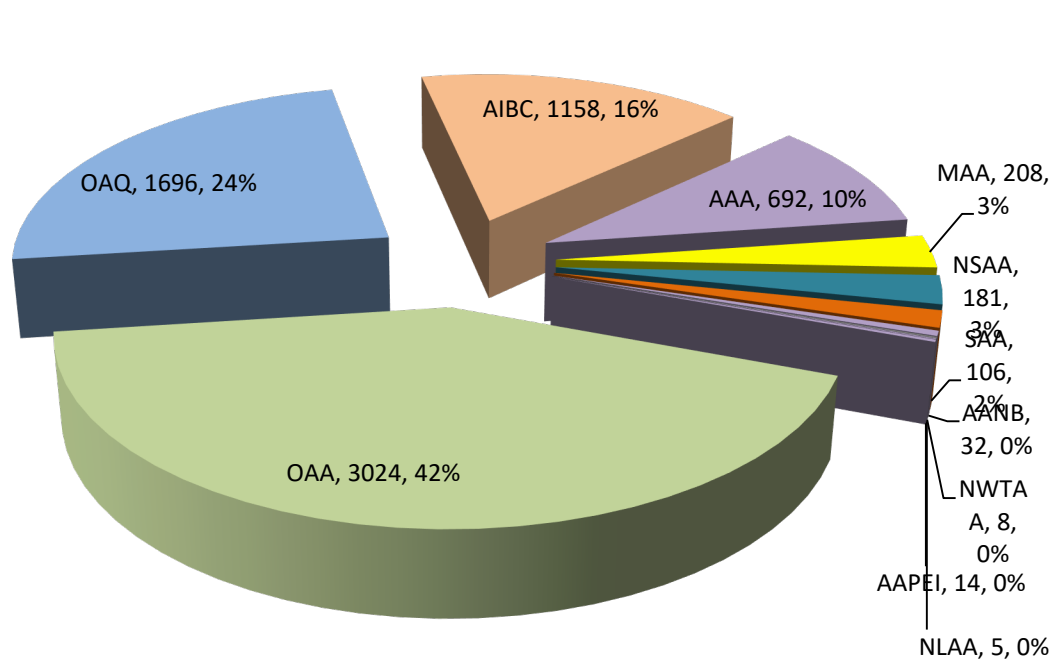

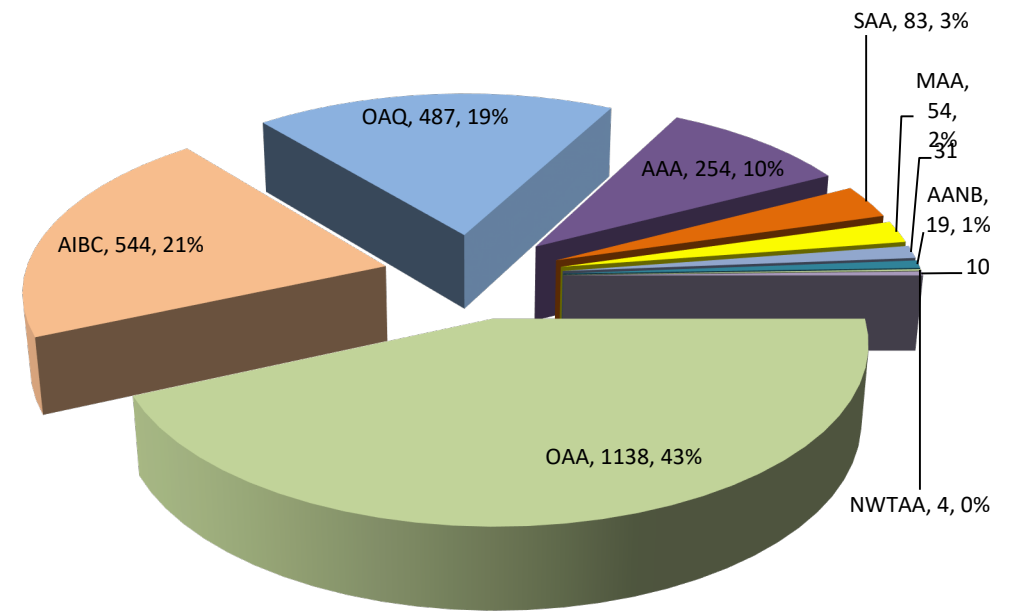


Total applications received showing Modes of Certification proportions as of February of each year

## APPLICATIONS RECEIVED BY JURISDICTION



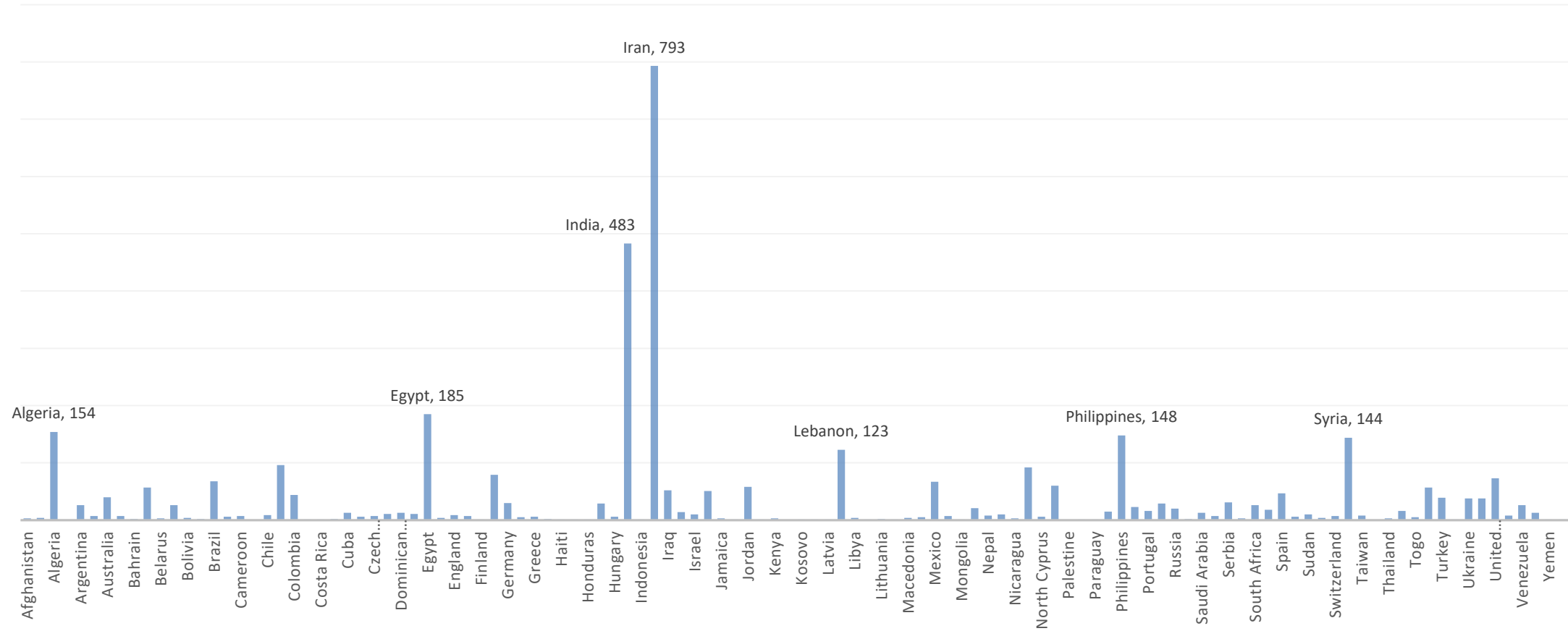

# **Automatic Certification for of graduates from accredited Canadian architectural degree programs**

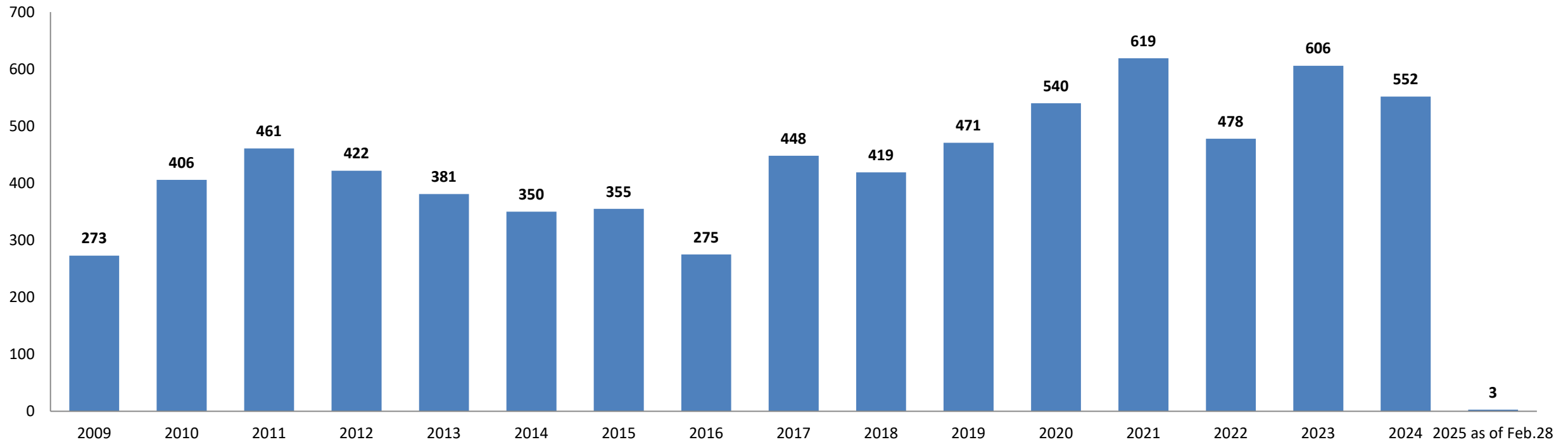
## Since 2009

In 2009, the CACB introduced the initiative for Automatic Certification of graduates from accredited Canadian architectural degree programs. Under this system, graduates are automatically granted certification upon receipt of the official list of graduates from their accredited institution.

This streamlined process encourages graduates to begin the licensing process by registering with the [Internship for Architects Program \(IAP\)](#), marking the first step toward becoming licensed architects in Canada
